

ARTICLE I - NAME

The name of this corporation is CHAUNCEY BELSER, INC. ,
hereinafter referred to as the "Corporation".

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the
date of the filing of these Articles with the Florida Department of
State.

ARTICLE III - PURPOSE

The Corporation may engage in any activity or business permitted


