ARTICLE I

CORPORATE NAME



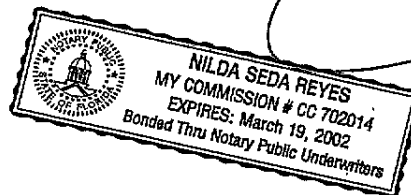
