The undersigned incorporator of this Corporation under Chapter 607, Florida Statutes, as amended, adopts the following Articles of Incorporation.

ARTICLE I

The name of this Corporation is: ENTERPRISES AEO, INC.

The principal place of business of this Corporation shall be 741 NE 114th Street, Miami, Florida 33161.

The Corporation shall have perpetual existence.

ARTICLE IV
