# ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF MUZIC DEPOT, INC.

OF TALLAHASSEE, FLORIDA

Pursuant to the provisions of \$607.0704, \$607.0725, \$607.0726, \$607.1001, and \$607.1003 of the Florida Business Corporation Act (the "Act"), Muzic Depot, Inc.(the "Corporation") adopts this Amendment to the Articles of Incorporation set forth below:

- 1. The name of the Corporation is Muzic Depot, Inc.
- 2. The principal address of the Corporation is 11891 U.S. Highway One, Suite 203 North Palm Beach, Florida 33409.
- 3. The following amendments to the Corporation's Articles of Incorporation were adopted by the unanimous consent of the board of directors and a majority of the shareholders entitled to vote of the Corporation on the 4<sup>th</sup> day of January, 1999 in accordance with and in a manner prescribed by the Act.

Article IV is hereby amended as follows:

## Article IV - Capital Stock

Article X is hereby adopted as follows:

### Article X - Amendment

The corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

Pursuant to \$607.0704(3), timely notice of the shareholder authorization obtained by written consent on January 4, 1999 has been provided to those shareholders who have not consented fairly summarizing the material features of the authorized action.
