

ARTICLES OF INCORPORATION

OF

LEVINE KATARI, P.A.

KNOW ALL MEN BY THESE PRESENTS, that I, the undersigned, do hereby associate myself into a corporation under and pursuant to the provisions and by virtue of the laws of the State of Florida and for that purpose do hereby make, subscribe, acknowledge, certify, and set forth as follows:

FIRST: That the name of the corporation shall be:

LEVINE KATARI, P.A.

SECOND: The resident agent and registered office of the corporation shall be as follows: Kimberly Levine Katari, 370 W. Camino Gardens Blvd., Suite 210, Boca Raton, Florida 33432, but the corporation may maintain offices, agencies, and places of business in any other state in the United States and in foreign countries without restriction as to place, and the corporation may keep such books, papers, and records of the corporation as are not required by law to be kept within the State of Florida and as the directors may find convenient, in such offices, agencies, and places of business.

THIRD: The specific purpose of the business is the rendering of legal services.

FOURTH: The amount of the authorized capital stock of the corporation is one thousand (1,000) shares of common stock with no par value.

FIFTH: The name and mailing address of the incorporator is as follows:

SIXTH: The Board of Directors of the corporation is expressly authorized to make, alter or repeal by-laws of the corporation, but the stockholders may make additional by-laws and may alter or repeal any by-law whether adopted by them or otherwise.

SEVENTH: The members of the governing board shall be known as directors and the number thereof shall be at least one (1), with the exact number and terms of office to be fixed by the bylaws of the corporation; provided, that at least one-fourth (1/4) of the members of the Board of Directors shall be chosen annually by the shareholders of the corporation.


EIGHTH: This corporation is to have perpetual existence.

TENTH: This corporation reserves the right to amend, alter, change, or repeal any provision contained in these Articles of Incorporation, in the manner now or hereafter prescribed by statute or by these Articles of Incorporation, and all rights conferred upon stockholders herein are granted subject to this reservation.


