ARTICLES OF INCORPORATION
OF

SEAHORSE TRAVEL, INC.

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is **Seahorse Travel, Inc.**

SECOND: The period of duration of the corporation is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States, or of this state.

FOURTH: The number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having a par value of \$1.00 per share.

FIFTH: This corporation shall have one (1) director initially. The number of directors may be either increased from time to time by the Bylaws, but shall never be less than one. The directors need not be residents of the State of Florida or shareholders of the corporation.

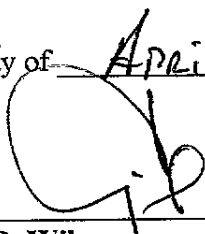

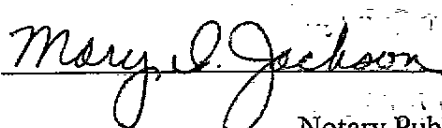

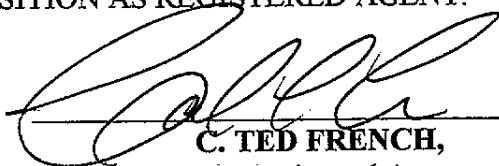
