In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is MRI International, Inc.

ARTICLE II

The existence of the corporation shall begin on April 28, 1998.

ARTICLE III

The street address of the principal office of the Corporation is c/o Sherri Simpson, 1868 N. University Drive, Suite 306, Plantation, Florida 33322.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1000, all of which shall be Common Shares.
