

**ARTICLES OF INCORPORATION  
OF

The undersigned, a natural person competent to contract, does hereby make, subscribe and file these Articles of Incorporation for the purpose of organizing a corporation under the laws of the State of Florida.

**ARTICLE I : CORPORATE NAME**

The name of this Corporation shall be: GOOD OLD FASHIONED CLEANING, INC., and its principal office shall be located at 10-B S.E. 1st Avenue, Delray Beach, Florida 33444.

**ARTICLE II: NATURE OF CORPORATE BUSINESS AND POWERS**

Indemnification of any other persons, such as employees or agents of the Corporation, or serving at the request of the Corporation as a director, officer, employee or agent of another corporation, partnership, joint venture, trust, or other enterprise, shall be determined in the sole and absolute discretion of the Board of Directors of the Corporation. Pursuant to Florida Statute 607.0850(9), no court order indemnification shall, under any circumstances, be permitted.

#### **ARTICLE X: AFFILIATED TRANSACTIONS**


This Corporation expressly elects not to be governed by Florida


