ARTICLES OF INCORPORATION

The undersigned subscriber, a natural person competent to contract for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation for such corporation.

ARTICLE I

The name of this corporation is DANNY ROWELL, INC.

ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III

This corporation is authorized to issue 1000 shares of (\$1.00) par-value common stock.

ARTICLE IV

This corporation shall have perpetual existence, unless dissolved in a manner provided by law.

ARTICLE V

The street address of the initial registered office of this corporation is 5112 Sterling Manor Drive, Tampa, Florida 33647 and the name of the initial registered agent of this corporation at that address is Danny Rowell and the principal office address of the corporation shall be 5112 Sterling Manor Drive, Tampa, Florida 33647.

ARTICLE VI

This corporation shall have one director initially. The number of directors may be increased from time to time by the bylaws, but shall not be less than one nor more than five. The name and address of the initial director of this corporation is:


ARTICLE IX



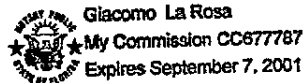
