## ARTICLES OF INCORPORATION OF

### L. L. NAILS AND SKIN CARE, INC.

The undersigned, acting as Incorporator of a Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such Corporation:

#### ARTICLE ONE

The name of this corporation shall be:

L. L. NAILS AND SKIN CARE, INC.

#### ARTICLE TWO
