Article I Name

The name of this corporation is CONTINUANT TECHNOLOGY SOLUTIONS, INC.

Article II Principal Address

14 Tara Lakes Drive East Boynton Beach, Florida 33436

Article III Commencement

This corporation shall commence on the date of the filing of these Articles.

Article IV Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

Article V Capital Stock

This corporation is authorized to issue 100,000,000 shares of, \$.0001 par value, common stock and 100,000,000 shares of, \$.0001 Par value, Preferred Stock, the rights and preferences of which shall be established by the corporation's Board of Directors.
