

ARTICLES OF INCORPORATION

For

Syl-Ron Enterprises, Inc.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

ARTICLE V SHARES


The number of shares of stock that this corporation is authorized to have outstanding at any one time is 1000 shares of no-par stock.
