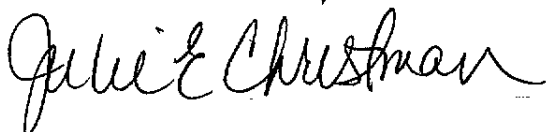

ARTICLES OF INCORPORATION
OF
CYBER BILLBOARD, INC.

ARTICLE 1 - NAME

The name of this Corporation is Cyber Billboard, Inc. and its address is 101 Woodlake Wynde, Oldsmar, Florida 34677.

ARTICLE II - DURATION

This Corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.
