The undersigned incorporator hereby forms a corporation under Chapter 607 of the Laws of the State of Florida.

ARTICLE. 1 NAME

The name of the corporation shall be **PAT & MIKE'S MARINE SERVICES, INC.**, and the address of the principal office of the corporation shall be 6474 Jupiter Landings Drive, Jupiter, Florida 33458, and the mailing address shall be the same.

ARTICLE 2. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.
