ARTICLE III

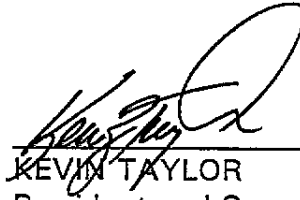

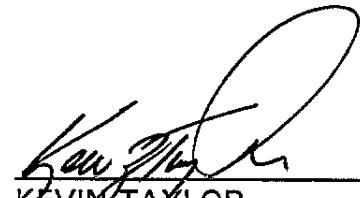
