THE UNDERSIGNED, acting as sole incorporator of **DSQ ENTERPRISES, INC.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation is DSQ ENTERPRISES, INC.

ARTICLE II

Effective Date

Initial Director


The corporation shall have one director who shall manage the corporation. The initial director shall be Catherine L. Avery.
