THE UNDERSIGNED, FOR PURPOSES OF FORMING A CORPORATION UNDER THE FLORIDA GENERAL CORPORATION ACT, HEREBY ADOPT THE FOLLOWING ARTICLES OF INCORPORATION:

ARTICLE I - NAME

The name of this Corporation is MICHELLE'S CUSTOMIZED CLEANING SERVICE, INC.

ARTICLE II - DURATION

The Corporation shall have perpetual existence commencing on the date of execution of these Articles.

ARTICLE III - PURPOSE

This Corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

The aggregate number of shares which the Corporation is authorized to issue is 1,000 shares, all of which shall be common shares with par value of \$0.01.

ARTICLE V - PREEMPTIVE RIGHTS GRANTED

The Corporation shall indemnify any officer, director, or any former officer or director, to the full extent permitted by law.

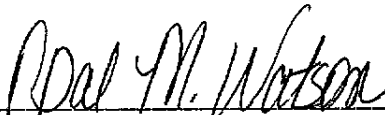
**ARTICLE X - AMENDMENTS**
