# ARTICLES OF INCORPORATION

#### OF

The undersigned Incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act.

#### ARTICLE I

#### Name

The name of the corporation shall be Tringham & Associates, Inc.

## ARTICLE II

# **Principal Office**

#### ARTICLE III

# Corporate, Purpose, Power and Rights

The purpose for which the Corporation is organized and operated is to provide various services related to the acquisition, financing, development, sale and operation of real property. More specifically, such purposes include, but are not limited to, the following:
