ARTICLE I - NAME

The name of this Corporation is FUTURE FIRST AVIATION, INC.

ARTICLE II - PURPOSE

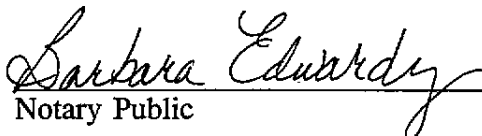
