ARTICLES OF INCORPORATION  
OF  
DIAL-A-MAID CLEANING AND MAINTENANCE, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles Of Incorporation:

1.

The name of the corporation is DIAL-A-MAID CLEANING AND MAINTENANCE, INC.

2.

The principal place of business and mailing address of the corporation shall be 4102 Cinnamon Way, Westin, FL 33331.

3.

The corporation shall have the authority to issue one class of stock consisting of not more than 100,000 shares.

4.

The name of the initial registered agent and street address of the initial registered office of the corporation in the State of Florida shall be Michael Solomon, 4102 Cinnamon Way, Westin, FL 33331.

5.

The name and address of the incorporator of the corporation is as follows:

The corporation shall have a perpetual duration.

7.

A director of the corporation shall not be personally liable to the corporation or its stockholders for monetary damages for breach of his duty of care or other duty as a director, except for liability (i) for any appropriation, in violation of his duties, of any business opportunity of the corporation; (ii) for any acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law; (iii) for the types of liability set forth in Section 607.0831 of the Florida Business Corporation Act (the "Act") or successor provisions; or (iv) for any transaction from which the director derives an improper personal benefit. If the Act is hereafter amended, then the liability of a director of the corporation shall be limited to the fullest extent permitted by the Act, as so amended. Any repeal or modification of the foregoing paragraph by the stockholders of the corporation shall not adversely affect any right or protection of a director of the corporation existing at the time of such repeal or modification.
