FLORIDA GENERAL CORPORATION ACT, HEREBY ADOPT THE FOLLOWING ARTICLES
OF INCORPORATION:

ARTICLE I - NAME

The name of this Corporation is PERSONAL FREEDOM TOURS, INC.


