ARTICLES OF INCORPORATION OF ROY BOWDEN CUSTOM MAPS, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

<u>Article 1</u>

The name of this corporation is Roy Bowden Custom Maps, Inc. The principal office and mailing address of the corporation are: 1226 Woodland Drive, Tallahassee, FL 32310.

Article 2

The duration of the corporation is perpetual.
