ARTICLES OF INCORPORATION OF
ROY BOWDEN CUSTOM MAPS, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

Article 1

The name of this corporation is Roy Bowden Custom Maps, Inc. The principal office and mailing address of the corporation are: 1226 Woodland Drive, Tallahassee, FL 32310.

Article 2

The duration of the corporation is perpetual.

Article 3

The general purpose of the corporation is to engage in and to transact all business which is lawful under the laws of the United States of America and the State of Florida.

Article 4

The aggregate number of shares which the corporation is authorized to issue is ten thousand (10,000) shares. All such shares shall be of a single common class. Each share shall have a par value of one dollar (\$1.00).

Article 5

The street address of the initial registered office of the corporation is c/o Mark Freund, Esq., Mark Freund, P.A., Suite 1101, 227 N. Bronough Street, Tallahassee, Florida 32301, and the name of its initial registered agent at that address is Mark Freund.

Article 6

The number of directors constituting the initial board of directors of the corporation is one. The number of directors may be increased or decreased from time to time in accordance with the corporation's bylaws but shall never be less than one.
