ARTICLES OF INCORPORATION  
OF  
HILTONELLI BROTHERS, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopts the following Articles of Incorporation:

ARTICLE ONE  
(NAME)

The name of the corporation is HILTONELLI BROTHERS, INC.

ARTICLE TWO  
(DURATION)

The term of existence of the corporation is perpetual.

ARTICLE THREE  
(PURPOSE)

The corporation is formed to engage in the business of manufacturing special fireworks, and may in addition engage in any and all lawful business for which corporation may be incorporated under the Florida General Corporations Act.

(CAPITAL STOCK)

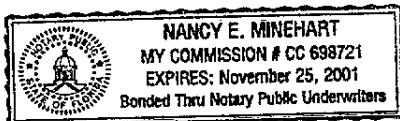
