ARTICLE I - NAME

The name of this corporation is CRJ OF LAKE MARY, INC.,
located at 301 Silver Pine Dr., Lake Mary, Florida, 32746.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing with the
filing of these Articles of Incorporation by the Florida Department
of State pursuant to the laws of the State of Florida.

ARTICLE III - PURPOSE

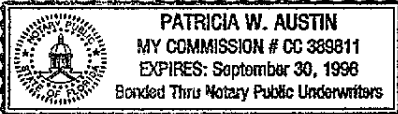
