OF

The undersigned subscriber to these Articles of Incorporation, Michael D. Spear, being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

ARTICLE I

CORPORATE NAME AND ADDRESS

The name of this Corporation is NATIONAL TELECOM SERVICES, INC., and the principal place of business is 1511 Cranville Square, Ft. Myers, Florida 33942

ARTICLE II

DURATION

The Corporation shall have perpetual existence, commencing upon the filing of these articles of incorporation.

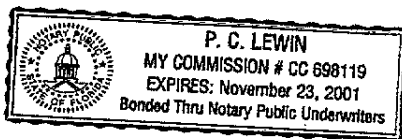

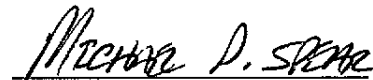
