# Articles of Incorporation of

**Fibrecrete System Builders, Inc.**

**WE, THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation for such corporation :**

**FIRST :** The name of the corporation is Fibrecrete System Builders, Inc..

**SECOND :** The period of its duration is Perpetual.

**THIRD :** The purpose(s) for which the corporation is organized are to operate a construction business  
“ and any other lawful business activity for which corporations may be incorporate under Chapter 607 of the Florida Statutes”.

**FOURTH :** The aggregate number of shares which the corporation shall have authority to issue is 1000 shares of common stock having no par value.

**FIFTH :** The corporation will not commence business until at least ONE THOUSAND DOLLARS (\$1000.00) have been received by it as consideration for the issuance of shares.

**SIXTH :** Cumulative voting of shares of stock is not authorized.

**SEVENTH :** There are no provisions limiting or denying to shareholders the preemptive right to acquire additional or treasury shares of the corporation.

**EIGHTH :** Provisions for the regulation of the internal affairs of the corporation are governed by the bylaws which shall be adopted by a majority of directors.

**NINTH :** The address of the initial registered office of the corporation is : 940 Eller Drive, Fort Lauderdale, Fl.33316 (Mailing address is P.O.Box 165563, Fort Lauderdale, Fl.33316), and the name of its initial registered agent at such office is Linda Cohen.

**TENTH :** Address of the principal place of business is 940 Eller Drive, Fort Lauderdale, Fl.33316.

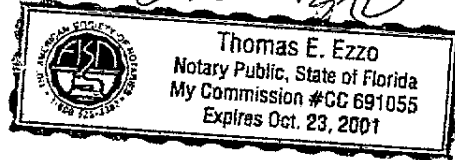

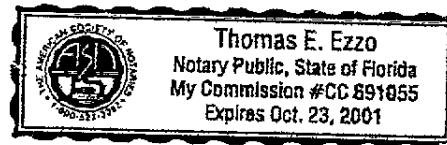
