

Article II - Principal Office; Mailing Address

The principal office and mailing address of this corporation is 501 North A1A, Jupiter, Florida 33477.

Article III - Capital Stock

This corporation is authorized to issue 7,500 shares of ONE DOLLAR (\$1.00) par value stock.
