This letter is to inform the Department of State of the circumstances which occurred causing the dissolution of Acribema Properties Corp. Acribema Properties Corp. was incorporated in May of 1998 and in 1999 we never received the Uniform Business Report (UBR) in order to maintain the corporation active. This is a real estate property, and, unfortunately, we were not aware that the UBR was required until this past year where we purchased two more properties, Fourmaris Properties Corp. and Bema-Acri Properties Corp. These two corporations received their UBR as scheduled, but Acribema Properties did not. This is when we realized the UBR had never been initially submitted. As shown on record at sunbiz.com Acribema was dissolved as of 1999, one year after its incorporation, the reason being we never received the first Uniform Business Report.
