ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be:

COMUNU MANAGEMENT SYSTEMS, INC.

ARTICLE II NATURE OF BUSINESS

The nature of the business and, the objects and purposes proposed to be transacted, promoted and carried on, are to do any and all things herein mentioned as fully and to the same extent as natural persons might or could do, and in any part of the world, VIS:

"THE PURPOSE OF THE CORPORATION IS TO ENGAGE IN ANY LAWFULL ACT OR ACTIVITY FOR WHICH CORPORATIONS MAY BE ORGANIZED UNDER THE GENERAL CORPORATION LAW OF THE STATE OF FLORIDA AND THE UNITED STATES GOVERNMENT."

ARTICLE III PRINCIPAL OFFICE

The initial post office address of the principal office of this corporation in the State of Florida shall be;

Mulberry, Florida 33860

The Board of Directors may from time to time move the principal office to any other address in the State of Florida.

ARTICLE IV CAPITAL STOCK

The maximum number of shares of stock that this corporation is initially authorized to have outstanding is 75,000 shares of common stock, having a par value of Ten Cents (\$0.10) per share. The Board of Directors shall have the authority to issue additional series and classes of stock pursuant to the provisions of the law and the By-Laws of the Corporation.

ARTICLE V INITIAL CAPITAL

This corporation shall begin business with that amount of capital deemed necessary by the Board of Directors.

ARTICLE VI TERM OF EXISTENCE

This Corporation shall have perpetual existence unless dissolved by action of law.

ARTICLE VII DIRECTORS

This Corporation shall have not less than one (1) Director initially. The number of Directors may be changed from time to time, by By-Laws adopted by the Stockholders.

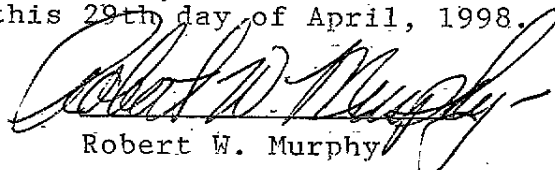

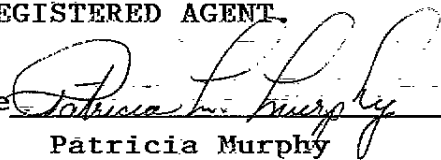
