ARTICLES OF INCORPORATION

OF

The Lobster Trap: Inc.

The indersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE L

NAME

The name of the corporation shall be: The Lobster Trap, Inc.

ARTICLE 11

PURPOSES

The purposes for which the corporation is formed and the business and objects to be carried on and promoted by it are as follows:
