ARTICLES OF INCORPORATION
OF
W.F.A., INC.
A FLORIDA CORPORATION

The undersigned, acting as Incorporator of a Florida corporation under the Florida General Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME

The name of the Corporation is W.F.A., INC.

ARTICLE II

DURATION

The Corporation shall have perpetual existence.

ARTICLE III

PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE IV

CAPITAL STOCK

The Corporation is authorized to issue 100 shares of Ten Dollar (\$10.00) par value Common Stock.

ARTICLE V
INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the Corporation is 1948 SE 16th Court, Pompano Beach, FL 33062, and the name of the initial Registered Agent of the Corporation at that address is Frank C. Rizzo.

ARTICLE VI
INITIAL BOARD OF DIRECTORS

The Corporation shall initially have (2) directors to hold office until the first annual meeting of shareholders and their successors shall have been duly elected and qualified, or until their earlier resignation, removal from office or death. The number of directors may be either increased or decreased from time to time in accordance with the Bylaws of the Corporation. 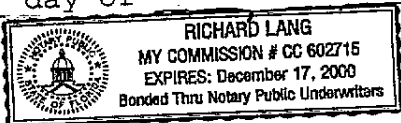
