ARTICLE I -- NAME

The name of this corporation is: AFFORDABLE LEGAL SOLUTIONS  
OF SARASOTA, INC.

ARTICLE II -- DURATION

This corporation shall exist perpetually.

This corporation is organized for the purpose of any and all

ARTICLE IV -- POWERS

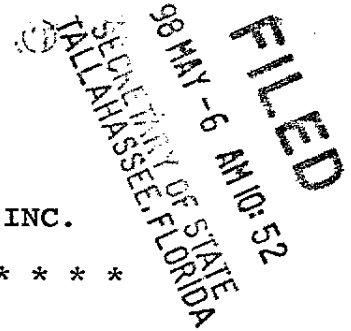
This corporation shall have all of the corporate powers

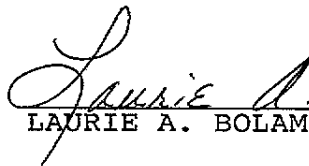

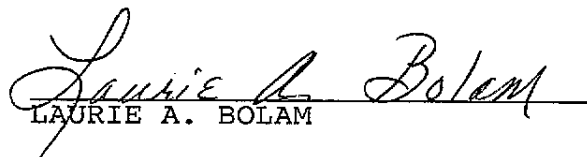
