EFFECTIVE DATE

NAME:

The name of the corporation shall be Mayer Family Enterprises Corp.

## ARTICLE II

## GENERAL NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

## ARTICLE III

## CAPITAL STOCK

The maximum number of shares of stock the corporation is authorized to have outstanding at any one time is 1,000 SHARES with a par value of ONE (\$1.00) DOLLAR per share.

#### ARTICLE IV

## INITIAL CAPITAL
