ARTICLES OF INCORPORATION
OF

The following Articles of Incorporation are made pursuant to the "Florida Professional Service Corporation Act", Florida Statute 621, as amended.

NAME AND PRINCIPAL OFFICE OF CORPORATION

The name of this corporation is ALLRADIO, INC., and the principal address and initial office of the corporation is 10113 Donhill Court, Orlando, Florida 32821

AUTHORIZED SHARES

Unless and until these Articles are amended, there shall be one (1) class of stock. The stock shall be common stock and the corporation shall be authorized to issue one hundred (100) shares of such stock, having no par value.

PREEMPTIVE RIGHTS

The corporation elects to have preemptive rights, said rights being pursuant to the principals applicable to such rights as described in the "Florida Business Corporation Act", as amended.
