Dear Mr. Scott:

I am writing in response to your notice of April 19, 2000 (copy enclosed). Your notice states that my corporation was administratively dissolved for failure to file its 1999 corporate annual report. I filed my 1999 corporate annual report on August 30, 1999 along with a check in the amount of \$550. (The only reason my annual report was filed after May 1, 1999 because I did not receive the original notice and only received a delinquency notice.) The Department of State cashed my check for \$550 (copy of front and back of check is enclosed). On December 14, 1999 the Department of state returned my document because it had not been signed by a registered agent. They did not return my check for \$550. In the notice they requested that I correct the document and stated if I returned it after January 1, 2000 I needed to send an additional \$150 to cover the fees for the year 2000.

On April 3, 2000 I returned the corrected document along with a check for \$150, as instructed in the letter (copy enclosed). In your notice of April 19, 2000, you returned my check along with the document. I believe this was in error as the Department of State cashed my check for \$550 back in September 1999 for the year 1999.

I have again enclosed my check for \$150 to cover the year 2000. Please correct your records and reinstate my corporation.
