The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME AND PRINCIPAL OFFICE OF CORPORATION

First Citrus, Inc. shall be the name of this corporation, and the mailing address and its principal office shall be: 2560 Gulf to Bay Boulevard, Suite 300, Clearwater, Florida 33765.

ARTICLE II - NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III - CAPITAL STOCK
