# ARTICLES OF INCORPORATION

of

## INTERNATIONAL DRIVE SOUTH DEVELOPMENT, COMPANY

The undersigned incorporator, being a natural person competent to contract, subscribes to these Articles of Incorporation to form a corporation under the laws of the State of Florida.

### I. NAME

The name of this corporation is International Drive South Development and its principle place of business is 2345 Sand Lake Road, Suite 120, Orlando, Florida. /Company


## ARTICLE X. By-Laws
