The name of this corporation is WILLIAM SNYDER, P.A.

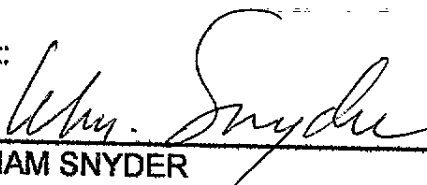
