ARTICLES OF INCORPORATION OF LODGESOUTH DESTIN, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME AND PRINCIPAL OFFICE

The name of this corporation is LODGESOUTH DESTIN, INC., and its principal office is located at 127 S. Alcaniz St., Pensacola, FL 32501, and its mailing address is the same.

ARTICLE II

DURATION

This corporation shall exist perpetually, commencing upon the date of filings in the second Articles of Incorporation.
