ARTICLE I - NAME

The name of the corporation shall be Anchor Invest. Corp. (hereinafter, the "Corporation" or the "Company").

ARTICLE VI - BOARD OF DIRECTORS

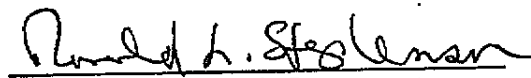
