## ARTICLES OF INCORPORATION OF FLORIDA STAR ENTERPRISES, INC.

The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

#### ARTICLE I - Name

The name of the corporation is **FLORIDA STAR ENTERPRISES**, INC. The principal place of business of the corporation is 2006 S.E. 21st Street, Cape Coral, Florida 33990. The mailing address of the corporation is 2006 S.E. 21st Street, Cape Coral, Florida 33990.
