**ARTICLES OF INCORPORATION  
OF  
FLORIDA STAR ENTERPRISES, INC.**

The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

**ARTICLE I - Name**

The name of the corporation is **FLORIDA STAR ENTERPRISES, INC.** The principal place of business of the corporation is 2006 S.E. 21st Street, Cape Coral, Florida 33990. The mailing address of the corporation is 2006 S.E. 21st Street, Cape Coral, Florida 33990.

**ARTICLE II - Commencement and Duration**

The corporation is to commence its corporate existence on the date of filing, and shall exist perpetually thereafter until dissolved according to law.

**ARTICLE III - Purpose**

The corporation is organized for the purpose of transacting any and all lawful business.

**ARTICLE IV - Stated Capital - Classes of Stock**

## **ARTICLE VII - Officers**

The initial officer(s) of the corporation shall be as follows:

GERTRUD ZÜCK-TARACH	- President/Secretary/Treasurer

## **ARTICLE VIII - Indemnification**

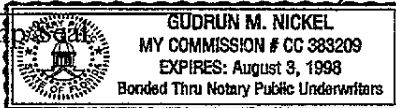
