# ARTICLES OF INCORPORATION OF PSI #20, INC.

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### **ARTICLE I**

## Corporate Name and Principal Office

The name of this corporation is PSI #20, INC. and its principal office and mailing address is 2000 N. Florida Mango Road, Suite 200, West Palm Beach, Florida 33409.

#### ARTICLE II

## Commencement of Corporate Existence

The corporation shall come into existence on May 6, 1998.

#### ARTICLE III

### General Nature of Business

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.

#### **ARTICLE IV**

#### Capital Stock

The aggregate number of shares of stock authorized to be issued by this corporation shall be 7,500 shares of common stock, each with a par value of \$.001.
