ARTICLES OF INCORPORATION OF PSI #21, INC.

The undersigned, acting as incorporator of the captioned corporation under the Florida

Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is PSI #21, INC. and its principal office and mailing address is 2000 N. Florida Mango Road, Suite 200, West Palm Beach, Florida 33409.
