The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

**ARTICLE I - Name**

The name of the corporation is **J&J NAPLES ENTERPRISES, INC.** The principal place of business of the corporation is 1701 Gulfstar Dr. #101, Naples, Florida 34112-0000. The mailing address of the corporation is 1701 Gulfstar Dr. #101, Naples, Florida 34112-0000.

**ARTICLE II - Commencement and Duration**

The corporation is to commence its corporate existence on the date of filing, and shall exist perpetually thereafter until dissolved according to law.

**ARTICLE III - Purpose**

The power to adopt, alter, amend or repeal bylaws shall be vested in the board of directors.

**ARTICLE XI - Pre-emptive Rights**

Every shareholder, upon the issuance of any new stock of this Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share at the price at which it is offered to others.


