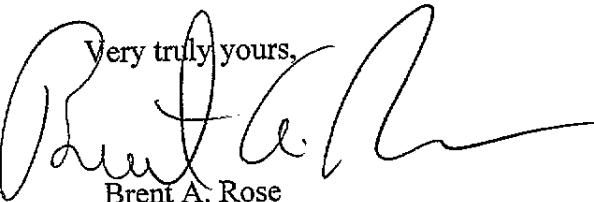

ARTICLE I. NAME AND ADDRESS

The name of this corporation is The Orsini & Rose Law Firm, P.A., and the address of the corporation shall be 405 Central Avenue, Suite 201, St. Petersburg, Florida 33701.

ARTICLE II. COMMENCEMENT OF CORPORATE EXISTENCE

In accordance with Section 607.167 Florida Statutes, the date when corporate existence shall commence is the date of subscription and acknowledgment of these Articles of Incorporation.

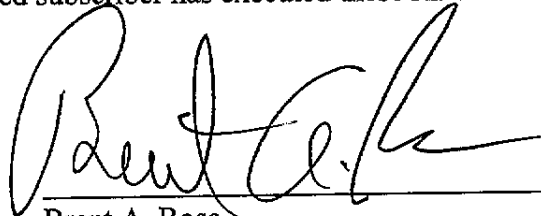
ARTICLE X. INDEMNIFICATION

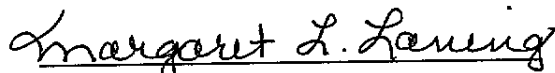

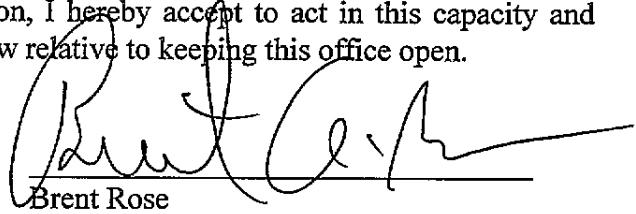
