

## Dear Sir/Madam:

This letter is written in regards to a "Notice of Administrative Dissolution or Revocation" that I just received in the mail. As you know, in this notice it states that my corporation "Great White Productions, Inc. has been administratively dissolved/revoked for failure to file my 2000 corporation annual report/uniform business report. It also states that a second notice was sent to me informing me that my corporation would be dissolved/revoked on or after September 13 if the report was not filed.

My concern is that I never received a first or a second notice informing me of the above mentioned circumstances. As a new corporation, I was aware of the fact that I did need to file this annual report, but in what time frame I did not know. I was assuming that I would receive a form to fill out from your organization in the time frame needed to submit it without penalty. I did not receive anything!

Very concerned about this matter, I called the number listed on the reinstatement packet, explaining my situation, and they said to fill in the forms sent to me to reinstate my corporation, along with the normal \$150.00 filing fee and a letter of explanation for the late filing. I am hoping that with this letter of explanation you will understand that I did not receive any notices of any kind concerning my filing of the 2000 annual report. Had I received a notice informing me of my deadline to pay before penalties would be assessed, I would have certainly paid it! As a small business, this is a hardship which hurts us immensely, and I would appreciate your understanding with this matter.
