## ARTICLES OF INCORPORATION OF JAFFE REAL ESTATE, II, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following articles of incorporation:

#### ARTICLE . NAME

The name of the Corporation is Jaffe Real Estate, II, Inc.

## ARTICLE II DURATION
