ARTICLES OF INCORPORATION

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

ARTICLE ONE

The corporate name is, AIRE SERV OF THE EMERALD COAST, INC.

ARTICLE TWO

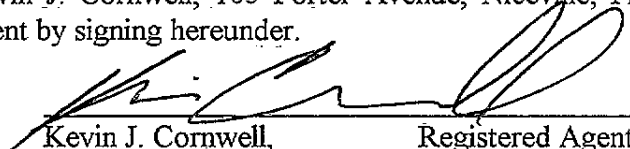

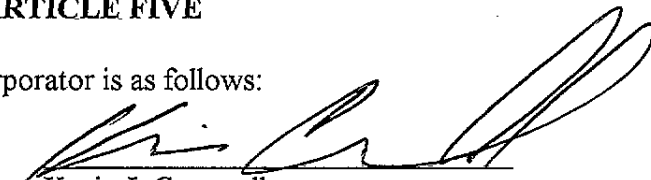
ARTICLE FOUR

ARTICLE SEVEN

The general purposes for which the corporation is organized are:

1. Maintenance, repair and installation of heating and air conditioning equipment in residential or light commercial buildings.
2. To transact any other business for which a corporation may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the stockholders of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
